OFFICIAL RULES**

SWEEPSTAKES ENTRY PERIOD: YouCam Apps “GHOST IN THE SHELL” MOVIE Giveaway

(“Sweepstakes”) begins at 12:00:01 AM Eastern Time (“ET”) on Monday, **March 6, 2017** and ends at 11:59:59 PM ET on Thursday, **April 6, 2017** (the “Sweepstakes Period”). Sponsor’s computer is the official timekeeping device for this Sweepstakes.

ELIGIBILITY: The Sweepstakes is open to legal residents of the 50 United States and D.C., excluding Puerto Rico, Guam, the Virgin Islands and other United States territories (the “U.S.”), age 18 or older at the time of entry who have Internet access, and an active Facebook, Instagram, or Twitter account. Void outside the U.S., and where prohibited by law. Ineligible persons: Employees, officers, directors of Perfect Corp.
